- **Application Deadline March 8:** \$150 per booth (10 X 10' with space between booths for better viewing), or \$280 for a double booth (10' x 20'). Notification of status will be mailed by March 29. **Applications after March 8:** \$170 per booth, \$300 for double booth. No applications juried after April 8. No refunds after March 30, 2018. Jury Fee of \$15, is non-refundable. “No-shows” forfeit booth fee. **Prior participation is not a guarantee of acceptance in the 2018 Festival.**
- **All pieces must be original and handcrafted by the Artist** - See categories listed on the Application. All pieces should be of excellent quality and design. Prints are acceptable if from artist's original work. Resale items, buy/sell imports, kits or commercial produced products are not allowed. The Festival Committee reserves the right to ask any artist to remove items that do not meet this guideline or are deemed inappropriate for family viewing at the discretion of the Festival Committee. All entries will be juried. We will limit the number of entries in each category in order to maintain a good “mix” of artwork. **Accepted artists will be featured on the Festival's Facebook Page.**
- **Artists are responsible** for staffing their booths during entire festival hours and for selling their own original artwork and collecting and paying Georgia sales tax (7% for Lumpkin County -Georgia).
- **Check-in/Set-up:** Friday, May 18 from 6:00 pm to 7:30 pm **or** Saturday, May 19, from 8 am to 9:30 am, at the Festival Headquarters in front of the Chamber of Commerce Visitors Center. Artists must register before setting up their booth and be open for business by 9:30 am Saturday and 10 am on Sunday. **No early take-downs.**
- **Booth set-ups and sharing:** Artists must provide their own booth set-ups, chairs, tables, and white or cream colored canopy. All tents must be weighted down. The exhibit space will be located on asphalt areas around the downtown square. We will provide space between booths for viewing and visitor access, but not as an additional display area. Have enough products on hand for the entire time. Early closing will jeopardize future participation in the Festival.
- \* **Sharing a Booth:** Two artists may share a booth. Each artist must submit an application and jury fee, but artists sharing a booth can submit **one check** to cover the booth fee.
- **Photographs/Images of work** must represent the work that you have created over the past 5 years and is representative of the work that you will exhibit and sell. Email 4 images of artwork and one of your booth display as part of your application to [orayneri@windstream.net](mailto:orayneri@windstream.net), **OR** mail a travel drive or photos with your application to Chestatee Artists, P O Box 572, Dahlonega, GA 30533.
